Reason	There were more electronic purchases because of the COVID situation as the last three months of this time period were completely remote. Being a performing arts school, we have high interest and use in streaming audio and video, which contributes to higher numbers in this instance.

Reason	Because of the increased purchases of ematerials, this total number for collections is naturally going to be higher.
